- 本申請案應於新生入學當學期註冊日起二週內提出，且以一次為限，超過期限不得提出申請抵免。Students shall apply for credits exemption according to the posted deadline and are limited to one application only. Students are not permitted to apply for credit exemption after finishing the exemption process or after the date of expiry.
- 應檢附成績單正本辦理學分抵免，**已取得學位者**請原畢業學校出具未列入最低畢業學分證明。Please provide the original copy of your transcript. Exempted courses should be the ones that have not been accounted into the minimum number of credits for graduation.
- 抵免之範圍與認定標準，由所屬系(所)依系(所)訂定之抵免辦法予以初核，初核通過者，再由註冊組依本校『學生抵免學分辦法』規定予以複核。Evaluation on the exempted courses and credits is determined by each academic unit. All academic units shall follow the evaluation guidelines strictly when carrying out preliminary and secondary reviews.
- 抵免學分數之上限依各系(所)之規定，惟最多不得超過本校抵免學分辦法規定應修畢業總學分數(不含畢業論文)之一半。Newly admitted master's/PhD students and students in graduate programs for working professionals shall not have more than half of total required graduation credits (not included dissertation) exempted. The exempted credits application of students who graduated from the University and take graduate programs in the University can be approved by their departments and are not limited by this rule.
